1. Acceptance of Terms

By signing up for our services, purchasing a membership (Basic, Business Directories, or Exclusive), or clicking "I Accept" where available, you enter into a binding legal agreement with Show Media LLC ("we," "us," or "our"). If you do not agree to these terms, you must not use our services.

2. Services Provided

3. Payment Terms and Authorization

- **Backup Funding:** If a Zelle payment is not received within the agreed timeframe, you explicitly authorize us to charge any Credit or Debit card we have on file for the outstanding balance to settle the debt.

3.3 Automatic Billing For recurring services or memberships, you authorize us to automatically charge your card or request Zelle payment on the specific renewal dates.

4. Non-Payment and Suspension of Services

4.1 Failure to Process Payment It is your responsibility to ensure that your payment method is valid and has sufficient funds. **If we are unable to process the payment** from your provided Credit/Debit card, or if a Zelle transfer is not received by the due date:

1. **Immediate Suspension:** We reserve the absolute right to **immediately suspend all services** without prior notice. This includes taking down websites, pausing social media campaigns, locking access to designs, and removing business listings until payment is successfully resolved.
2. **Legal Action:** In the event of unresolved non-payment, refusal to pay after services are rendered, or fraudulent chargebacks, Show Media LLC reserves the right to initiate **legal proceedings** to recover the owed amounts. You will be responsible for all associated costs, including legal fees, court costs, and collection agency fees.

5. Refund Policy

Unless explicitly stated otherwise in a specific service agreement, all fees paid to Show Media LLC are non-refundable once the work, design process, or service setup has commenced.
